## TERMS:

- 1. Nothing in this agreement shall prohibit or conflict with a deputy performing his sworn duties at any time.
- 2. Requestor shall not require deputies to perform any duty contrary to their oath.
- 3. Requestor shall pay a minimum of \$53/hour per deputy or employee.
  - a. A minimum of 4 hours per deputy/employee (each) shall be charged to requestor.
  - b. Payment shall be made directly to the Financial Office of Haywood County.
  - c. Payment shall be made no later than 5 days from first date of service and then on an ongoing bi-weekly basis.
- 4. The Sheriff reserves the right to accommodate other entities as necessary in the name of public safety.
- 5. This contract shall be interpreted under North Carolina law and venue shall be in Haywood County, NC.
- 6. All complaints, if any, shall be directed to the Special Assignment Coordinator of the Haywood County Sheriff's Office in a timely manner and in no case no later than 48 hours after an issue arises.
- 7. If any portion of this contract is deemed unenforceable all other provisions shall remain in full force and affect.
- 8. Termination of this contract at any time, by the Sheriff's office, shall not constitute a breach of this agreement, so long as any remaining funds are refunded in a timely manner.
- 9. The Sheriff retains the right to call in any or all deputies from this assignment at his sole discretion, or if an emergency arises, without committing a breach of contract.
- 10. Requestor agrees and warrants that they shall indemnify, subrogate and hold harmless the Office of the Sheriff and the Deputies and personnel used for this assignment.
  - a. Requestor agrees to be responsible for all legal fees, costs or damages, if any occur, for any deputies, equipment or property as a result of this assignment.
  - b. If any part of this contract is breached, the Sheriff's Office shall be entitled to reasonable legal fees if they should prevail.
- 11. By signing this Special Assignment Contract, the Sheriff of Haywood County or his designee, accepts the request and application for services and agrees to the aforesaid terms.
